Recent situation of Ukraine as an export market for organic raw materials

POSITIVE ASPECTS

- Ukraine is known for its large agricultural potential, a lot of interesting and requested products are able to grow in Ukraine (such as soy, sunflower, rape seed, spelt, high proteine wheat).
- A lot of serious pioneers are producing for many years
- Organic associations and support structures are present
- Conversion to organic farming makes sense for Ukrainian farmers because of the independence of expensive agricultural inputs



Recent situation of Ukraine as an export market for organic raw materials

NEGATIVE ASPECTS

- Today organic end products with the declaration "EU agriculture" related to the European organic label can still not be produced with Ukrainian raw materials
- Fraud cases
- Perception of legal uncertainty also due to the military conflict in the Eastern part
- Difficulties to organize transports due to the recent economic situation of Ukraine less trucks are available to transport goods into the EU.
- Sometimes opportunistic attitudes and shortterm thinking of Ukrainian organic farmers, which avoids long term agreements.

- Customers like to know where their products come from, that means that Ukrainian organic farms must be presentable regarding each aspect of their production
