Meaning of Organic Agriculture

- "Organic agriculture is an ecological production management system that promotes and enhances biodiversity, biological cycles and soil biological activity.
- It is based on minimal use of off-farm inputs and on management practices that restore, maintain and enhance ecological harmony.

It is important to focus on

- Holistic approaches
- Technical progress
- Minimum tillage and correct crop rotations
- Improving consumer-oriented food quality
- Improving ecological and socio-economic values
- Ensuring future seed and animal breed supply for organic farming (GMO-free).

Threats

• Organic agriculture is under threat of several aspects basically priority expectation is different from different parties. This has a direct influence on the quality and integrity of organic products.

Producers

- Majority of the producers do not understand the idea of organic philosophy, they are more concentrated in to profit.
- Producers are under pressure of the market demand and fulfill agreements they made with the buyers.

Trader

- Traders are the engine of the market development, they invest a lot for infrastructure, personnel, logistics to guarantee supply chain.
- There are traders believing in organic farming, investing, supporting local communities, working hand in hand to develop the organic agriculture.
- There are also some traders consider organic product is an item to make extra premium, good market, without belief in organic philosophy.

Certifier

- There are many certification bodies operating and usually new ones have no experience how to deal with for complicated situations
- They usually do not have knowledge how to deal legal issues
- Accreditation is usually achievable therefore many certifiers accredited nowadays have no basic experience to deal with problems faced in organic product supply chain.
- When certification of organic product is considered as a product certification without believing in organic philosophy, failure is unavoidable.

Local Authorities

- Authorities of the importing countries expect every single pack of organic product needs to be free from chemicals, most of the time no residue is the approach.
- Traceability in demand starting from the single plot of the fields, up to the final delivery to the final consumer. Varieties, quantities must be proven. Additional supplier audit is required.
- In third countries Local authorities in many cases do not understand organic farming practices, even majority do not believe organic production and think it is easy money making process.

Politics

- Support of organic producers through state funds is a political tool for the interest of politician.
- Chemical industry, GMO Lobby have more influence over the politics therefore politicians are more tend to work in favor of them.

Laboratory Based Approach

- Considering the sensitivity of organic products to be free from chemical residues, leads risks of compliance to the regulation requirements.
- Everybody involved with the organic product supply chain feels obliged to make tests. Local authorities as well does regular tests.
- Question is: Is organic production laboratory based technique, every step of the production, processing marketing to be analyzed? It reflects to the retail prices and consumer needs to pay.
- Laboratories flourishing around, in fact sarcastic, when the chemical industry, GMO lobby increasing its turnover and power.

Final Questions

- Could we see future for organic production when GMO lobby and Chemical industry continuously invading agriculture?
