Some aspects of reporting in the field of organic production, circulation and labelling of organic products

{As amended by the Order of the Ministry of Agrarian Policy and Food No. 971 of 05.12.2022}

In accordance with <u>paragraph four</u> of part four of Article 28, <u>part three</u> of Article 36 of the Law of Ukraine "On Basic Principles and Requirements for Organic Production, Circulation and Labelling of Organic Products" and <u>clause 8</u> of the Regulation on the Ministry of Agrarian Policy and Food of Ukraine approved by the Resolution of the Cabinet of Ministers of Ukraine No. 124 of 17 February 2021, **I HEREBY ORDER:**

- 1. To approve the enclosed documents as follows:
- 1) Reporting procedure of the certification body on the certificates issued by it;
- 2) Procedure and frequency of declaration and submission of consolidated records on the volumes of organic products put into circulation.
- 2. To repeal the Order of the Ministry for Development of Economy, Trade and Agriculture of Ukraine of 31 December 2020 No. 2834 "Some aspects of reporting in the field of organic production, circulation and labelling of organic products" registered with the Ministry of Justice of Ukraine on 17 February 2021, No. 200/35822.
- 3. The Department of State Policy in the Field of Sanitary and Phytosanitary Measures shall ensure submission of this Order for state registration to the Ministry of Justice of Ukraine in accordance with the established procedure.
 - 4. This Order shall enter into force on the date of its official publication.
- 5. The Deputy Minister shall be responsible for control over the implementation of this Order in accordance with the distribution of responsibilities.

Reporting Procedure of the certification body on the certificates issued by it

- 1. This Procedure establishes the procedure, form, and timeframe for the certification body to submit a report on the certificates it has issued to the State Service of Ukraine on Food Safety and Consumer Protection and to the Ministry of Agrarian Policy.
- 2. In this Procedure the terms shall be used in the meanings set out in the <u>Law of Ukraine</u> "On Basic Principles and Requirements for Organic Production, Circulation and Labelling of Organic Products."
- 3. The certification body shall draw up a report on the issued certificates (hereinafter referred to as the report) in the form presented in the Annex to this Procedure.
- 4. The report shall be drawn up in the state language as of 31 December of the reporting year and submitted to the State Service of Ukraine on Food Safety and Consumer Protection and the Ministry of Agrarian Policy in electronic format by 10 February of the year following the reporting period.

The reporting period is considered to be the year from 01 January to 31 December of the reporting year inclusive.

- 5. If the last day for submitting the report is a public holiday, the working day following it shall be considered the last day for submitting the report.
- 6. If an error is detected in the submitted report, the certification body shall draw up and submit a new report to the State Service of Ukraine on Food Safety and Consumer Protection and to the Ministry of Agrarian Policy before the deadline for submitting the report.
- 7. The certification body shall keep the reports submitted to the State Service of Ukraine on Food Safety and Consumer Protection and to the Ministry of Agrarian Policy for a period of three years.
